Full payment of the application is due at date given above. If you are taking advantage of a discounted rate, full payment is due by the deadline date indicated. Refunds are available if, for whatever reason, you cannot attend the event. However, the amount of your refund is dependant on when you withdraw.

**6 months prior** to the event will incur a fee of \$500.00 CDN. The balance will be returned within 90 days; however, the entrant may apply their entire entry fee towards entering the next year's event.

**Cancellation between 6 months and 2 months** prior to the event will incur a fee of \$1,000.00 CDN. The balance will be returned within 90 days following the event; however, the entrant may also convert all but \$500.00 CDN towards entering the next year's event.

**Cancellations within 2 months** prior to the event will incur a fee equal to 50% of the entry fee paid by the entrant. The balance will be returned 90 days following the event; however, the entrant may convert all but \$1,000.00 CDN towards entering the next year's event.

**Entrants who fail to appear** or withdraw after registration will forfeit their entire entry fee.
